

COLLABORATION AGREEMENT

This Collaboration Agreement is entered into by and between Odessa Law institute of Kharkiv University of internal affairs and Yeditepe University, Law Faculty

1. SUBJECT OF AGREEMENT

1.1. Following the necessity of perfection of training of future lawyers, aspiring to expansion of scientific-practical connections, with the purpose of study and experience exchange of educational-experimental work of Odessa Law institute of Kharkiv University of internal affairs and Yeditepe University, Law Faculty made up the further agreement.

1.2. This Agreement, in whole and in part, shall be interpreted and construed under the Laws of Ukraine and Turkey.

2. BASIC COLLABORATION DIRECTIONS

2.1. In the sphere of scientific-research activity the basic directions are:

2.1.1. realization of scientific and training-methodological works which are being created by Odessa Law institute of KhUIA and the Law Faculty of Yeditepe University.

2.1.2. innovation into the education and training of the Odessa Law institute of of KhUIA and the Law Faculty of Istanbul University the experience of practical activity of law researches results;

2.1.3. participation in scientific-practical seminars, conferences, symposiums, meetings and also other scientific-methodical arrangements which the Sides perform;

2.1.4. permanent exchange of experience and information on research work of higher educational establishments of Ukraine and Turkey.

2.2. In the sphere of educational-methodical activity the basic directions are:

2.2.1. permanent exchange by experience and information on educational and methodical providing of training subjects, introduction and organization of the credit-module system into educational process of law faculties of Ukraine and Turkey;

3. RIGHTS AND DUTIES OF SIDES

3.1 In the case of necessity the Sides have a right:

- to give up the realization of the activity not foreseen by this Agreement;
- to make additional agreement within the limits of current legislation of Ukraine and Turkey.
- to make the creative groups for the scientific researches;
- to attract scientific, practical, scientific-research, educational organizations and establishments, unions, and also the separate scientists and practical collaborators for general scientific programs and projects realization.

3.2 The sides of this Agreement are obliged:



- to promote the new scientific researches and to give necessary practical and theoretical help;
- to inform immediately about the changes of the legal addresses and other

essential elements to each other.

4. FINAL POSITIONS

- 5.1. This Agreement is concluded in two copies and has equal lawful force.
- 5.2. This Agreement **sets up from** the moment of his conclusion and acts permanently.
- 5.3. This Agreement can be terminated on the mutual agreement of the Sides or on both sides initiative or separately in accordance with current legislation of Ukraine and Turkey.
